The BREULAW project: an EU-funded programme immersing European lawyers


What is the BREULAW project?

BREULAW, the short name for "Development of a lawyer's training curriculum in EU law and study visits to EU institutions in Brussels", is a project co-funded by the European Union and run by a consortium composed of the CCBE and the European Lawyers Foundation (ELF). This project, which commenced on 1 February 2023 and will last for a duration of 24 months, aims to contribute to the EU's objective of continuing training on EU law reaching 15% of lawyers in the EU. The BREULAW project derives from the study on the state of play of lawyers' training in the EU and its relevant recommendations, and is based on previous CCBE projects and policy documents, such as, for example, CCBE recommendation on Training Outcomes for European lawyers adopted in 2007.

Both the development of the curriculum and the study visits (photo 1 and 2) are considered of crucial importance in the training of lawyers in order to improve their skills in EU law and their understanding of the EU institutions.

What are the main objectives of the project?

Developing a European lawyer's training curriculum in EU Law

The curriculum will be published during the upcoming months and will comprise of a check-list of the principles and procedures which practising lawyers should be aware of in order to ensure a proper application of EU law in their everyday working lives. In addition, there will be expected training outcomes listed at the beginning of each of the sections of the curriculum, explaining the concrete skills, knowledge and practical abilities that the curriculum aims to see realised.

Since initial and continuous training of lawyers are within the competence of the national Bars and Law Societies, and each national Bar has its own approach, the curriculum is aimed to be flexible enough to fit in with national approaches, while still ensuring a coherence and harmony in EU law training across Member States.

• Study visits to the EU institutions in Brussels

This is the first time that an EU-wide programme enabled lawyers to participate in study visits to Brussels to learn first-hand about the work undertaken by the EU institutions. Previous programmes had included visits to the Court of Justice of the European Union (CJEU) but not the EU institutions in Brussels (the European Commission, the European Parliament and the Council of the EU). The visits also included a visit of the CCBE premises and a presentation of the CCBE activities.

The CCBE is delighted to be involved in this project and the feedback it has received from the participants, which has been extremely positive.

CCBE Plenary Session in Lausanne

he CCBE held its Plenary Session on 17 May 2024 in Lausanne, Switzerland.

The meeting was opened by CCBE President, Pierre-Dominique Schupp, and welcomed two external speakers:



- Yves Donzallaz, President of the Supreme Court of Switzerland (photo 1), who delivered a speech on the independence of judges and the judicial system.
- Lucie Du Pasquier, Scientific expertise and publications manager of the Jean Monnet Foundation for Europe (photo 2), who presented the work of the Foundation and highlighted the comprehensive body of resources it has on the history of European integration.

The CCBE Presidency and the delegations subsequently discussed various matters, including on the development of a lawyer's training curriculum in EU Law, human rights, deontology, the Court of Justice of the European Union (CJEU) Hearings' Recording as a Judicial Training Tool, and the CCBE long-term strategy with respect to the work carried out by the CCBE Future Strategy Task Force on this matter.



Further to the fruitful discussion on numerous topics, the following items were approved:

CCBE statement on the situation of lawyers in Tunisia



On the day of its Plenary Session, the CCBE published a statement strongly condemning the recent violent arrest of Tunisian lawyers Sonia Dahmani and Mehdi Zagrouba, as well as the acts of torture perpetrated against him, and the attempted arrest of lawyer Nidhal Salhi. The CCBE unanimously expressed the solidarity of the entire legal profession in Europe and invited the competent authorities at EU, Council of Europe, and international level to take the necessary measures to support these lawyers.

CCBE position paper on the proposal for a
Directive laying down minimum rules to prevent
and counter the facilitation of unauthorised
entry, transit, and stay in the Union



As outlined in its position paper, the CCBE is particularly concerned with the vague definitions of the provisions of this proposal, which do not address the declared objective of clarifying which offences should be criminalised. As a result, the proposal may impact lawyers providing legal advice in the field of migration and asylum law, as well as risks having a chilling effect on lawyers and criminalising legal assistance. Therefore, the CCBE requests EU legislators to clarify the wording and include a mandatory, explicit, unambiguous, and broad-in-scope solidarity clause.

CCBE key principles and best practices in the relationship between lawyers and legal expenses insurers



The CCBE published a document presenting six key principles and best practices in the relationship between lawyers and legal expenses insurers. Based on a set of national practices reported in certain countries, the key points essentially recall the principle of the free choice of a lawyer and its legal consequences. It also promotes effective legal protection through the assistance of a lawyer, and it seeks to avoid inappropriate obstacles arising from insurance companies' practices.

CCBE paper regarding AML supervision and practices by Bars and Law Societies



The CCBE issued a report on key findings based on the data it collected from its members from 2022 to 2024 on the supervisory measures and practices by Bars in the field of anti-money laundering (AML). The aim of the paper is to facilitate the exchange of information amongst Bars and Law Societies in the hope of also providing inspiration. Furthermore, it is hoped that the findings will inform the EU legislators in regard to AML.

The key findings indicate that Bars and Law Societies are very engaged in undertaking their supervisory duties under the AML framework and that the majority of Bars enabled by law to do so have put in place supervisory measures to ensure that the AML framework is complied with by lawyers. In addition, the paper provides some recommendations where there is room for improvement.

CCBE proposals for the upcoming online ECtHR application form



In the context of the current development of an electronic application form by the European Court of Human Rights (ECtHR), the CCBE identified practical points arising from the use of the ECtHR's current application form. These points are based on the practical experiences of lawyers and are intended to assist the ECtHR in addressing some of the practical difficulties which have arisen with the current application form.

Main CCBE Events & Activities

14.05.2024

High-level meetings at the Council of Europe

series of high-level meetings between the CCBE and the Council of Europe took place on 14 May 2024 in Strasbourg, France. The importance of the future European Convention on the Protection of the Profession of Lawyer, one of the CCBE's current priorities, was a main focus point of the discussions.



The CCBE President, Pierre-Dominique Schupp, and Secretary-General, Simone Cuomo, were honoured to meet with Council of Europe Secretary-General, Marija Pejčinović Burić (photo 1 and 3). The meeting was an excellent opportunity to exchange on the ongoing cooperation between the CCBE and the Council of Europe, with a particular focus on the European Convention on the Protection of the Profession of Lawyer. In addition, the meeting provided the chance to delve into the latest artificial intelligence developments and their impact on legal processes, which the Secretary-General had previously highlighted during a CCBE high-level panel discussion for European Lawyers Day 2023.

The CCBE representatives also met with Christos Giakoumopoulos, Council of Europe Director General on Human Rights and Rule of Law, and Gerald Dunn, Council of Europe Secretary to the European Committee on Legal Co-operation (CDCJ) (photo 2 and 4). The discussions emphasised the crucial work of the Council of Europe in supporting the European legal profession, defending the rule of law, and upholding human rights.

The future Convention on the Protection of the Profession of Lawyer was on the agenda of the discussions, together with other important topics, such as justice and the rule of law, family law and children's rights, public law, as well as promoting and facilitating the operation of Conventions within the CDCJ's remit.

In addition, various pertinent topics were discussed during the events, including the role of Bars and Law Societies during national elections, artificial intelligence and professional ethics, as well as the independent regulation of legal services. European Judicial Training Conference: supporting the digitalisation of justice

n 25 and 26 April 2024, the European Commission and the Belgian Judicial Training Institute organised the European Judicial Training Conference in Brussels, Belgium. During the conference, the CCBE Secretary-General, Simone Cuomo, as well as the CCBE Senior Legal Advisor, Indra Bule, and several CCBE experts (photo 1) provided their contribution for the upcoming European Judicial Training Strategy and repeatedly stressed the need to ensure that all legal professionals, including the lawyers, should equally benefit from judicial training on EU law supported by EU funding. The CCBE considers this of the utmost importance, especially in view of the developments regarding the digitalisation of justice.

Providing lawyers with similar training resources at an EU level to that which exists at a centralised level for judges and prosecutors would contribute to maintaining a fair, effective, and consistent legal system, as well as facilitate access to justice for citizens and promote respect for the rule of law.

Access to data by law enforcement authorities

n 15 April, the CCBE sent a letter to the High Level Group on Law Enforcement Access to Data, co-chaired by the European Commission's DG Home Affairs and the Belgian Presidency of the Council. The group, set up in June 2023, was examining the current regulatory landscape on access to data by law enforcement authorities. The CCBE raised concerns about the protection of confidentiality of lawyer-client communications and recalled several principles that should apply to all regimes regulating access to data by government authorities.

n 23 April 2024, the CCBE Permanent Delegation to the ECtHR (PD STRAS) held a roundtable to have an exchange between the CCBE, the Plenary Assembly of the Council of Europe (PACE) and Government Agents before the ECtHR on how to improve the execution of ECtHR Judgements. The roundtable (photo 1 and 2) gathered Roman Zavrsek, CCBE Vice-President; Isabelle Niedlispacher, Belgian Agent before the European Court of Human Rights; Givi Mikanadze, Chair of the PACE Sub-Committee on the Implementation of Judgments of the European Court of Human Rights; Constantinos Efstathiou, PACE Rapporteur on the Implementation of Judgments of the European Court of Human Rights; and members of PD STRAS.

Overall the discussion was very appreciated and interactive and participants agreed that collaboration between all represented should be further promoted in order to further improve the execution of ECtHR Judgements.





Regulation amending Protocol n°3 on the Statute of the Court of Justice and of the amended rules of procedure of the Court of Justice and of the General Court

11.04.2024

he Regulation amending Protocol n°3 of the Statute of the Court of Justice with the partial transfer of preliminary rulings to the General Court has been adopted by the co-legislators, the European Parliament and the Council. The final act was adopted on 11 April 2024.

Since then, the Council has been working with the Court of Justice to amend the rules of procedure so as to fully implement this reform on the operational side of the Court of Justice and General Court. The CCBE Permanent Delegation to the Court of Justice and the General Court and the EFTA Court Committee examined the draft amendments to the rules of procedure of both courts, and prepared some comments in response. These comments were submitted and discussed by the Court of Justice and Council during their meeting on 26 April 2024.
